

**INFORMATIVE CALCULATION OF STUDY GRANT – ADVANCE ON THE STUDY GRANT**  
**Academic year 2021-2022**

You pay a **reduced tuition fee** when you are a scholarship student in accordance with the guidelines of the Study Grant Department. If the income is situated just above the maximum limit (up to € 3.227,00 – amount of 2020-2021), you are a near-bursary student. You will not receive a scholarship, but you are entitled to a lower tuition fee. Student Services can calculate whether you qualify for a study grant.

In addition, you can apply for **an advance** on your study grant.

Therefore we need you to fill in this document.

**What happens after the informative calculation?**

Student Services will inform you and the student administration of your campus whether you are entitled to the reduced tuition fee and/or a study grant. Based on this notice, the reduced tuition fee will be granted and you can ask for an advance on the study grant. Nevertheless, if the Study Grant Department decides that you are not allowed to have a study grant (e.g. due to an altered family situation or changed incomes), you will receive additional invoices to pay the tuition fee.

**PLEASE NOTE!**

- This is **NOT an official application** for the study grant from the Flemish Government. You must apply for this grant yourself via their website [www.studietoelagen.be](http://www.studietoelagen.be) or your application will be opened automatically by the Study Grant Department of the Flemish Government if you received a study grant last year. In that case you have to complete your file.
- The official period to apply for a study grant is between 02/06/2021 and 01/06/2022. However, Thomas More expects of you to **apply before 31/01/2022**. If not, in February you will be seen as a non-bursary student and you will receive an additional invoice in expectation of the final decision of the Study Grant Department.

- You are married, in a legal partnership, or actually living together and you have one or more children resulting from that relationship.
- You and your partner, starting from the date of your marriage, legal partnership, or birth of a child resulting from that relationship, have acquired an income of at least € 7 671,25 over a period of 12 months (these months do not have to be consecutive), and this no later than 31 December 2022. For income out of labour a gross taxable income for 2021 of at least € 10 958,93 is needed.

**Self-sufficient student**

You are a 'self-sufficient student' when you can prove self-sufficiency on 31 December 2021. A self-sufficient student must be able to prove an acquired income of at least € 7 671,25 over a period of 12 months (these months do not have to be consecutive). For income out of labour a gross taxable income for 2021 of at least € 10 958,93 is needed.

A separate domicile is not a requirement.

5. If you are married, in a legal partnership, or actually cohabiting with a partner with whom you have a child, then add all income from yourself and your partner from 2019 until 2021.
6. If the owner-occupied home is used for professional purposes, or if (one of) the house(s) is not owner-occupied, please add a copy of the notice of property tax assessment (tax year 2020).
7. Copy of attestations of non-taxable income of 2019 (social security, integration or income replacement benefits for people with a disability, non-taxable grant)
8. Copy of attestation confirming the percentage of disability (disability of +66%).
